General Comments

Upon my arrival the children were going outside.

It was a little cold outside this morning and so the children did not stay outside long as some were getting cold. Please ensure that children have weather permitting outdoor clothing such as mittens, warm jackets, hats and boots to ensure they stay warm so playtime can occur closer to the time required in the regulation of one hour per four-hour block.

The outside playground has many different areas for play including a mud kitchen, a playhouse, a music area and a newly added nature section. This morning the children were playing with the water table as the water had formed into ice and the children were interested in playing with the ice.

When we came inside, Krista had purchased new magnetic puzzles for the children and so they did the puzzles together. Then the children played with learning materials/toys of their choice.

The indoor space is clean and organized. There are materials and equipment in sufficient quantity and variety for all children present. There are different learning materials such as art and craft materials, blocks, language and literacy, fine motor and puzzles. The materials are provided on low open shelves making the material accessible to the children.

There is evidence of purposely planned programming using a web format. The children's learning is documented using photographs and learning stories. Some learning stories are posted on the walls and in a binder. Some of the children's projects are also on the walls.

Krista was engaged with the children in play and conversation. Positive child guidance was observed such as encouragements and positive reinforcement. For example: when the children were eating and using their utensils or when they were picking up their toys during clean up. Krista was also observed talking to the children at their level.

Around 11:15, the children washed their hands and then had lunch. The table was replaced with a smaller table

which allows for more independence, and the children can sit themselves. It also provides more space for highchairs for the children that need it. Krista sat at the table with them and engaged in conversation, they talked about their weekend and what they have in their lunch today.

Around 11:45, Krista started getting the children ready for nap time. They read a book together and everyone then went into the nap room. The children went to sleep immediately with no difficulty.

Everything is in compliance today, I recommend for renewal.
