Comments: Out of 13 child records reviewed, one was missing the address and telephone number of the child's medical practitioner. The Quality Assurance Monitor reminded the administrator that all child records must include the name, address, and telephone number of the child's medical practitioner.

Comments: Of the 13 child records verified, one was missing the full address for both listed emergency contacts. The Quality Assurance Monitor reminded the administrator that each child record must include the name, address, and telephone number of two individuals to be contacted in the event of an emergency.			

<p>General Comments</p> <p>The Quality Assurance Monitor is on site to conduct the renewal inspection. Child-to-staff ratios is maintained throughout the visit.</p> <p>During the inspection, the Quality Assurance Monitor observed children arriving from school, having a snack, and engaging in indoor free play. The Quality Assurance Monitor also observed children preparing to go outside for outdoor play.</p> <p>A discussion took place between the administrator and the Quality Assurance Monitor regarding child records. The Quality Assurance Monitor noted that several child records listed "Moncton Hospital" as the child's medical practitioner. The Quality Assurance Monitor advised that parents should indicate if their child is on a waitlist for a medical practitioner or note that the child currently does not have a medical practitioner, rather than listing a hospital or clinic.</p>
