Comments: Some of the structures in the playground do not have the required depth of protective surface as indicated by the manufacturer's instruction manual. The Operator must ensure that the correct amount of protective surface is in place before the children are allowed to use the play structures.			
33(2) Stationary equipment in the outdoor play area shall be surrounded by a protective surfacing and installed according to the manufacturer's instructions.	33(2)	Oct 14, 2021	
Comments: Some of the stationary equipment in the playground do not have the required depth of protective surfacing. The operator must ensure that the correct amount of protective surfacing is in place before the children are allowed to use the play structures.
