General Comments

The inspector observed the nap time, children having their snacks and indoor freely play.
An educator of the infant room is singing and dancing with the children.

The inspector observed an educator seated at the table on her phone on multiple occasions during indoor free play. The inspector discussed with the administrator regarding the importance of educators actively engaging with children—either by joining their play or encouraging participation in other meaningful activities.

The inspector observed that a staff member does not have a vulnerable sector check on their criminal record check. The administrator must ensure that all staff members that have access to the children has a vulnerable sector check conducted.

Educators have until August 31, 2025, to complete their professional development hours. Some educators are working on them.
