<p>General Comments</p> <p>Monitoring inspection performed. This is my first time visiting this facility since it opened in January. Very warm and inviting.</p> <p>Centre is following Covid guideline, completing children's daily log sheet (first and last name) and screening licensing personnel prior to entry.</p> <p>Children were observed playing outside their fenced in area. I was advised that the school age play area was being used as an outing for the children.</p> <p>Both groups of preschoolers were enjoying a story being read to them before washing up to eat lunch. Lots of wonderful age appropriate educational programming observed following the child's lead and educators were extending learning opportunities. One group is learning about Ocean Life and the other group have been learning about wasps and bees. During quiet time the educator put on Ocean sound music.</p> <p>Attendance records were reviewed and these are in order. I also reviewed staff information. One staff is currently enrolled in the 30 hour Intro to ECE. .</p> <p>I observed staff sitting and eating with the children which is a wonderful social experience for all. I observed lots of positive interaction between the children and educators. They were observed engaged and participating in play.</p> <p>3 nappers today and the other children were enjoying a quiet play time.</p> <p>The compliance requirement listed above was addressed during my visit. Please remind staff to store all cleaning products including undiluted Quats locked under the sink in the kitchen. Though the Operator is aware this cabinet needs a new lock , so today all cleaning products were moved to the electrical room which is locked until the operator purchases a new lock. Thank you.</p>
