It has been indicated that there is an educator on staff that will not turn 19 until November. It is just a reminder that any educator under the age of 19 cannot be left alone at any time.

The Director of facility stated that they did not have to use potential illness forms so licensing staff did not verify current documents. Director is aware that these forms must be used for any illness related departure by staff or children.
