| <p><b>General Comments</b></p> <p>The Administrator is efficient with record keeping of the children and staff files. Children were observed getting ready for outdoor playtime, playing outside and coming back inside for lunch. Staff were actively involved with the children as noted by reading stories, sliding down the hill during outdoor playtime and sitting on the floor playing with the infants. The microwave in the staff room is being used to heat up the children's lunches. This microwave has burn marks on the inside and should be replaced. A few broken toys were noted in the outside play space. One pink tricycle has a broken seat. This item needs to be removed from the play area. One classroom has too many materials in it and has a very cluttered appearance. There are bags of items, an extra table and an empty fish tank on the floor under the table. This area needs to be cleaned and organized to get optimum use for the classroom.</p> |
