Comments: Proper handwashing and disinfecting procedures were not followed.			

<p>General Comments</p> <p>Children were finishing up snack when licensing staff arrived. After snack the children were able to have some free play while the rest of the children finished eating their snack.</p> <p>An established routine was observed in the preschool room as noted during bathroom breaks and hand washing. The children are interested in polar animals and today's craft was making a narwhale with socks and stuffing. Each child has a family photo book available to look at whenever they want.</p> <p>The infant rooms were mark making with pastel sticks and markers. One room was set up at a table while the other room was using highchairs. I recommend a table be added to this infant room that way the children do not have to sit in their highchairs for too long. Also, the diaper changing table is very wobbly. The screws need to be tightened, or the table should be replaced. This room is also missing a ceiling tile since the summer. This needs to be replaced.</p> <p>The two's room was engaged in some free play activities, with most of the children playing the large connect 4 game.</p> <p>Throughout the facility the shelves are labelled in a variety of languages. There seems to be a good supply of loose parts and building materials such as lego and building blocks.</p>
