- 2-year-old group: educator was signing songs. They then went outside.
- 3 year old to afterschool age groups had the choice to go outside or stay inside because of the warm weather.
- Educator with 4-5 year old was searching pictures of real animals because the children were asking what the pictures they were looking at were in real animal versions.
