<p><b>General Comments</b></p> <ul style="list-style-type: none"> <li>- Visit completed at the facility in the afternoon for a monitoring inspection.</li> <li>- During the visit, the required staff-to-child ratios were respected.</li> <li>- The minimum space between rest equipment was at least 46 centimeters. All nap equipment was washable and non-absorbent.</li> <li>- The following documents were posted in a visible and prominent location at the entrance of the facility: the licence, inspection reports, orders for compliance, daily routine, evacuation procedures, the name of the administrator, the name and telephone number of the Quality Assurance Monitor and the inspector and when it applies a notice to inform parents of the existence of a communicable disease.</li> <li>- Administrative records are maintained on-site. Monthly emergency evacuation and fire drills are completed.</li> <li>- A daily incident log is maintained. Parents are advised of incidents and signs the daily log.</li> <li>- Personal belongings are labelled with the child's name. Easily accessible and stored separately for each child.</li> <li>- Observations: 2-year-old room: Upon my arrival, children were napping. After waking from nap, the children participated in a gross motor activity, washed their hands, and ate their snack provided by the parent. 3-4- year-old room: During the visit, children were napping. Children who were not napping were playing quiet games on their cots. After waking from nap, the children participated in a painting activity. 4-year-olds room: Upon my arrival, eight children were napping and six children were playing outside. The children also participated in a fine motor activity.</li> <li>- Discussion with the director on communicable diseases. During the visit, I provided her with the new communicable disease posters.</li> </ul>
