following: past renewal reports, license, emergency and evacuation drills, daily routine, contact information, and allergies. Several forms of documentation were observed throughout the cottage- clay creations drying on a shelf, open ended artwork, photos of the children taking part in activities, and several learning stories. Today, the children were observed during outside play. Children were observed in the Maple Grove area. Children and educators were observed playing "The Floor is Lava". A group of children were observed sitting at a picnic table, drawing and coloring. Another group of children were observed exploring nature. Educators were engaged with the children, taking part in play, and conversing with the children. Attendance records were observed and accurate.
