Comments: Licensing staff presumes cleaning of bathrooms is taking place daily, but it was observed the bathroom cleaning checklist was missing from one of the bathrooms. The other bathroom it was last recorded the end of the first week of August. Cleaning should be tracked daily using appropriate disinfectants as per public health frequency requirements. Please commence documentation. It was also observed the sink in the infant bathroom needs to be re-caulked as this presents a health hazard or interferes with sanitary maintenance. There are diapers stored underneath the sink also that could get wet from water spilling around the sink. Children's diapers should be stored off the floor. Please also removed the labels on the bottles used in the infant play area as they pose a danger to children as this age group mouths toys.

The educator corrected this during my visit and relabeled the water bottles.								

Upon arrival, all educators were in the classrooms. It is pouring rain today, so licensing staff didnot observe children in outdoor play, though in past visits children have been observed enjoying outside play. One class took advantage and organized some music to give children opportunities to be active. Children listened and freeze danced and sang along to the children's music. This would be recommended that other classrooms follow the same lead and add some active play opportunities to their programming when the weather is forecasting heavy rain.

Administrative records were reviewed and educator and child attendance is tracked (please ensure child's first and last name are on the attendance sheet - this was corrected during my visit), infant toddler records completed, incident reports are documented, and potential illness form was completed and signed by the parent for a child that left sick yesterday. Just a kind reminder the fire extinguishers are due for servicing in November and recommend completing prior to your licensing renewal inspection.

Lots of positive child guidance was observed. Educators used pleasant conversation with the children. Licensing staff observed children being comforted, educators' were overheard saying - ' thank you, use gentle hands around our friends, awesome job, no thanks, hands on your head to show me that you are listening please and thank you' etc. Children were also assisted and supervised during bathroom breaks.

Eventhough staff child ratio's were being met during my visit, licensing staff observed that children who were signed in on one attendance sheet were signed out shortly after arrival and moved to another room in order to meet ratio today. Consistency is extremely important and frequent changes of staff and play areas is not a good practice and should be avoided as it can be upsetting to a child's routine. This was being done because the centre was short staffed, the casual was unavailable, and 2 regular staff are on leave and do not return until October. It is my understanding a new educator is being hired for the preschool room starting on Monday, but this doesnot address all the staffing issues. Please ensure parents are made aware their children are being moved and have given permission. This should be documented. A plan should be in place for staffing shortage. Children were observed napping during my visit and all staff were required to be in classrooms to meet the ratio, however another staff arrived at lunch hour to cover staff lunches.

Love the infant family wall. Children were observed engaged in many activities. Educators interacted with children by calling them by their names. The babies love listening to all the different sounds. Educators have added different materials to the bottles, however, please ensure the labels are removed.

Lots of interaction was observed in the other classrooms when reading the story "I am mad', other groups listened to music, other children were observed dressed up playing superheroes, playing house in the kitchen and pretending to cook food and children were also invited to the table to participate in a group painting activity. This is also a reminder the renewal application was due on September 1st. Please complete the application and submit to me on or before September 19th.
