General Comments

This is a follow up monitoring inspection.

Upon arrival the 3's and 4's were finishing lunch and then a few children were observed going for a nap and were assisted by educators. One child asked to have their back rubbed and the educator complied with the child's request. The other children played quietly on a mat on the other side of the room.

The babies and 2's were also napping and were also observed waking and assisted with toileting and putting on

outdoor shoes for outdoor play activities. The 3- and 4-year-olds were listening to a story about "every child matters after their nap and quiet time before going outdoors. The infant educators were observed playing children's music and singing with children.

Enough staff were on site to meet child staff ratio and children were not being moved to meet ratio during this visit.

Administrative records were reviewed, and attendance was tracked, infant toddler records were completed, a fire drill was performed end of September, potential illness form was completed on Oct 2 for a child that left the facility ill. Please ensure all sections of the potential illness form are completed ie. departure time was missing and should be documented on the form and stored in the child file.

As a follow up to educator PL requirements - please read comment above.
