A renewal inspection was conducted today. The children were observed during morning snack, outside free play in both fenced in area and outdoor classrooms, inside play, circle/story time, lunch and nap/quiet time. The children's learning is documented and displayed in each of the learning environments. There is a wide variety of age-appropriate loose parts available for the children to interact and engage with. Educators were observed having positive interactions with the children in their care during the inspection. Recommending that all emergency exits plans be redone and the new divisions of the rooms that have occurred since the initial licensing of the facility, be indicated on these drawings.
