Comments: Room 1B - Two soothers were observed in the nap room, in two separate cribs. Soothers, when not in use, are to be labeled and stored separately for each child.  Room 2B - One soother was observed in the play area. Soothers, when not in use, are to be labeled and stored separately for each child.			

### General Comments

A Monitoring Inspection was conducted this morning. Children were observed inside during free play, and during the transition to outside play. The following rooms were observed - 1A, 1B, 2A, 2B, 3, 4A, & 4B.

All rooms were observed to have several well-defined learning / play areas. Several forms of documentation were observed in each room. A conversation was had regarding the placement of some of this documentation. Several examples were posted too high, preventing the children from seeing the documentation. It is recommended that all documentation be at the children's level.

Educator files were observed, and all new staff were added. One educator's Criminal Record / Vulnerable Sector check had recently expired. This educator is not to be left alone with children, until they get an updated check added to their file.

A conversation was had regarding the cleaning schedule. Two educators were observed sweeping / changing garbage during QAM's morning visit. It is recommended that cleaning be completed at the end of day, allowing

for a fresh start, each morning.

### Rooms:

1A - Educators stated that the children are presently interested in the outdoors, painting, and building / stacking. Children were observed sitting with an educator, listening to a story, and stacking wooden pieces, at the Tuff tray.

2A - Educators stated that children are presently interested in singing, dancing, and anything sensory related. Children were observed playing with homemade Play-Doh and reading books.

2B- Educators stated that children are presently interested in running, sliding, and toy cars. Children were observed running and playing with toy cars.

3 - Educators stated that the children are presently interested in space, rocket ships, cutting, and arts & crafts. Children were observed in the hallway, getting ready for outside play.

4A & 4B - Children were observed getting ready for outside play.

The parent board was observed, and it contained the following documentation: Renewal & Follow-Up reports, most recent Monitoring Inspection Report, daily routine, contact information, license, and a list of allergies.
