General Comments
<p>Room 1 A & B QAM observed documentation displayed on the walls related to outdoor activities and purposefully planned learning experiences. Both sides of the room contained invitations including cars, a cotton-ball activity, and drums. Materials for arts, blocks, and literacy were present. During the transition from indoors to outdoors, educators used singing and verbal prompts.</p> <p>Room 2 A & B QAM observed documentation on the walls related to outdoor activity experiences. Outdoor play areas contained trucks, cars, dramatic play materials, and playhouses. Both rooms transitioned from outdoors to indoors. Educators organized children into small groups for removing outdoor clothing.</p> <p>Room 3 QAM observed documentation related to current learning projects, including numbers, outdoor play, and kindness. Invitations included painting, magazine cutting, and magnets. In the outdoor classroom, children engaged with a parachute, dramatic play materials, fort-building materials, and trucks. Educators were present and participated in activities with children.</p> <p>Room 4 A & B Room 4A: QAM observed children engaged in outdoor play, including wooden houses, hammocks, dramatic play materials, musical instruments, and natural areas. Room 4B: QAM observed the group indoors following outdoor play. Children washed hands, and educators read a story while others completed handwashing. Educators and children interacted during the story. Both sides of the room contained materials for arts, dramatic play, blocks, and literacy, along with documentation of a family project and outdoor activities.</p> <p>Attendance records and child-to-educator ratios were accurate and current in all four rooms.</p>
