General Comments
<p>A renewal inspection occurred today.</p> <p>The children in the preschool room were observed outside in the outside classroom for the majority of the renewal inspection. The children went inside before lunch for a break and to wash hands before heading back outside for their lunch.</p> <p>The outside classroom provides an area for the children to explore nature. With the addition of the "deer fencing" around the entire outside preschool classrooms, this ensures the safety of the children while they enjoy nature and the outdoors.</p> <p>Discussed with Executive Director and Educators of the preschool room having a backpack, with the children's labelled sunscreen in it. This will make it easier for the educators when they need to reapply this on the children. Thus, saving the group time of going inside every time it needs to be re-applied. Educators are to ensure this backpack is hung high, out of the reach of the children at all times.</p> <p>The children's learning is documented and displayed in the inside learning environment. Pictures, captions, art and learning stories are displayed low on the walls for the children to revisit at their leisure.</p> <p>Educators were observed actively engaged with the children in their learning and play. Educators were observed speaking appropriately to the children and responding and tending to their needs.</p>
