<p><b>General Comments</b></p> <p>Preschool children were having snack when I arrived for today's monitoring visit. Once snack was done, children were asked to use the washroom and then get ready to go play outside. School aged children were not present when I arrived as they were still in school.</p> <p>Once there were enough preschool children who were ready to go outside for one educator, that educator took them outside to play, while the second educator continued to help the other children get ready. Dividing the group up in this manner helps cut down the wait time of the children who are ready and getting warm during transition instead of waiting for everyone to get ready and head out together.</p> <p>While children were getting ready, educators were observed encouraging the children to try and get ready themselves, all while ensuring they stayed close for those who still required assistance.</p> <p>While outside, the children were excited to use two outside play spaces since the school age children were still in school. Educators ensured they positioned themselves to ensure that each outside play space always had an educator present for supervision purposes.</p> <p>Today was a half day of the school aged children. When they arrived at the facility they went directly outside to play for a bit before coming in for lunch. They will be going on a field trip today to Odell Park to go sliding.</p>

General Comments

Educators assured all children were wearing their "Go-Go vests" before leaving to get on the bus. Observed educators taking roll call before getting on the bus and again once they reached their destination and were off the bus. Once they arrived at O'Dell, educators were handed a schedule with different activities they could do with the children. Some of these activities were a nature hike, playing at the park and sliding.

Educators were observed playing and being attentive to the children at time of visit.

Observed an abundance of words of encouragement, praise and positive child guidance during today's visit.
