Upon arrival at the facility, the children were engaged in free play activities such as playing in the dramatic play kitchen and signing and dancing with the educators to some music. One educator was observed picking up toys during this time.

The indoor environment was well organised and clean. The children's personal belongings were well stored in their labelled cubbies. The daily routine was posted on the walls along with the parent information board. The parent information board was verified and found to be complete. Learning stories such as "volcanoes" and tiedye butterflies were posted on the wall with art and crafts that the children made. There was also a "family tree" with pictures of the children's families. In the classroom, there was loose parts materials, an arts and craft section, a "cozy corner" with age-appropriate books, a ball pit, dramatic play corner with a kitchen and stage, and a creation station with building blocks, Legos and magnetic blocks. All play materials were located at an accessible height for the children to access. Documentation was included for each "theme week" when asked, the educators showed the lesson plans for each week. Daily attendance was taken, and the child and staff profiles were found to be complete.

After engaging in free play activities, the educators asked the children to wash their hands before sitting at the table to have their lunch. The children agreed and proceeded to wash their hands and sit at the table. The educators were observed opening snacks for the children and encouraging the children to put their shoes on and sit down while eating. The educators were observed sitting at the table with the children while they ate. After snack, the educators encouraged the children to get ready to head outside to play in the playground. The children put on their outdoor shoes and hats on before going outside. The educators were observed taking the first aid bag and the attendance records to playground. Before going outside, the educators were observed completing a head count before going outside with the children.

While outside, the children played with hula hoops, a little cart and some balls. Please ensure that the mud kitchen items that are being shared in the tree playground are available to the pre-school aged children while playing outside. Please ensure that the play materials that are located outside of the fence to be routinely picked up and brough to the playgrounds. The educators were observed playing with the children and engaging in their interests. One educator was observed carrying a child that was crying as they fell. The educator was observed

soothing the child and sitting with them until they returned to play. While outside, the educators were observed applying sunscreen to the children and offering water to them. There were no hazards present in the playground at this time.

After playing outside, the educators asked the children to line up at the gate, completed a head count and returned inside. While inside, the children washed their hands, took out their lunch boxes and ate their lunches. The educators ensured that all children washed their hands before eating. The educators were observed opening the children's lunch containers and sitting at the table with them. After lunch the children engaged in free play activities while the educators sanitized the tables and chairs and swept the floors.

After cleaning, one educator prepared a planned activities in relation to "unicorn and rainbow week". The educator was observed placing a bin of "rainbow sand", spoons, bowls and strainers on the table. One the activity was ready, the children engaged in the "exploration bin". After engaging in free play and the "exploration bin" the educators asked the children to gather on the space mat for story time. The educator was observed reading a book to the children. After story time, some children took a nap while others engaged in quiet time activities.
