General Comments

Children were outside playing and waiting for the Go-Go bus to arrive when I arrived for today's renewal inspection. To help the little ones get on and off the bus, the bus driver ensured to have a little step stool with him to assist the children in making that first big step onto the bus. Observed all educators performing head counts before and after everyone loaded the bus, the same was observed when they were returning to the Early Learning and Childcare facility.

Children were very fortunate to go on a fieldtrip to the Capital Community Church for a puppet show! Children were observed laughing and smiling throughout the whole production, as were their educators. There were even chances for the educators and children to go on stage and participate in some activities. Kids were able to participate in an activity where they first had to unroll a roll of toilet paper with their elbows (toilet paper roll was on a broom handle to ensure it would spin), then after that there were offered the choice to put masks on and use their heads! Another activity was that they had to try and shovel easter eggs in a basket, all while being blind folded. But I think what the children really enjoyed was watching their educators get up on stage and have a contest over who could eat a fruit by the foot the fastest without using their hands.

When children returned to the ELC facility, they were able to play outside for a little while before heading in for lunch. During lunch, some educators were observed sitting with the children while other ensured they were moving around the room to assist any children that may need help.

There is a quiet time at the facility where children are encouraged to play quietly and relax with the lights dimmed down and there is calming music playing. Those children who wish to have a nap are provided with a

cot should they wish.

The facility's indoor environment offers a very bright and caring atmosphere for children to grow, learn and thrive in. All classrooms have an abundance of learning materials that meet the interests of the children. The indoor environment is also set up in a way that promotes independence by having all play material on low shelves so that the children can pick and choose what they wish to play with.
