General Comments
<p>Children were outside playing when I arrived at the facility for today's monitoring inspection.</p> <p>Facility has added an all-natural section to their fenced in play area. The area contained a wooden playhouse, wooden tables, wooden chairs made out of tree stumps, wooden kitchen, a little wooden bridge, balance beam, etc.</p> <p>Children heard an airplane flying over head and were observed excitedly running over their educator asking her to check where the plane was coming from and where it was going. Educator took the time to take out her phone, sit with children and was able to track the plane. Children were discussing the plane's route before educator let them know that it was coming from Toronto and flying in the Fredericton airport. Observed educator finding a broken toy and put it over the fence to be thrown out.</p> <p>Children were observed asking their educator if they could have water play. Educator then proceeded to get a couple water tables/bucket ready for the children to play with.</p> <p>Educators were observed doing an art activity with the children while they were outside. They were observed taping paper on one of the slides, putting paint on the paper and children went to the top of the slide and let their car/truck down. This created a bunch of car/truck tracks on the papers. Children were also observed painting at a picnic table.</p> <p>Facility has installed a TV at the main entrance that plays a slideshow of pictures of activities that the children</p>
