### General Comments

Upon the licensing staff's arrival, the children were on a field trip. During this time, licensing staff verified the child profiles, daily information, parent information board, and the staff profiles. All documentation was up to date and completed. The indoor environment was bright, clean and well organized. All of the children's personal belongings were labelled and properly stored in their cubbies. Multiple pictures of the children are posted on the walls along with learning stories and recent spring artwork. Attendance was taken and complete.

Upon the children's arrival, one group came inside to use the washroom and wash their hands before going to play outside. The educator was observed counting the children before going outside. The other group of children remained outside and played in the playground. Licensing staff observed the children play with digging utensils, making mud pies, digging in rocks, playing on the play structure and sandbox. The educators were observed applying sunscreen to the children while outside. A reminder was given to the educators to ensure that they change their gloves in between each application of sunscreen. The educators were in touch with the children's needs at all times. Outdoor materials were sufficient and varied. The outdoor environment was clean and was free of hazards.

After playing outside, one educator was observed doing a head count before going inside for lunch. The educator remained patient while the children took off their outdoor shoes and put their outdoor shoes in their cubbies. The children were observed washing their hands before lunch. An educator was observed sanitizing the lunch tables before encouraging the children to gather their lunch boxes and have lunch.

During lunch the educator was observed opening food containers and observing the children while they ate. The educator was also observed preparing the children's beds for nap time. After lunch, the children washed their hands before engaging in free play activities with toys from home. Other children were observed laying down on their beds and reading books.
