<p>General Comments</p> <p>Upon arriving the children were engaged in free play activities such as playing with magnetic blocks, dolls and in the dramatic play area. One educator was observed engaging in play while another educator was preparing an indoor obstacle course for the children. In the other room, the educators were preparing a painting activity for Valentines Day. Verbal prompts were given to the children during transition times, and the educators were observed helping the children clean up their activities. Once the obstacle course and painting activity were ready, the educators invited the children to partake if they wanted to. The educators and children were heard cheering each other on as the children completed the obstacle course. The educators were heard praising the children and taking pictures of the activities for documentation and learning purposes.</p> <p>Later, a fire drill was completed with the children of the larger classroom. Daily attendance and first aid bags were brought outside during the fire drill. Once the children returned inside, they engaged in free play activities such as playing in the dramatic playhouse, coloring and playing with toy trucks. The educators were observed engaging in the children's interests and encouraging them to share materials. One educator was observed reading a book with a group of children and asking them questions to make connections to their home lives. Before transitioning to lunch time, a verbal prompt was given, and music was put on to encourage the children to clean up. The educators were observed sanitizing the tables and setting out the children's lunch boxes. The educators demonstrated strong and positive child guidance and were in touch with the children's needs.</p> <p>The indoor environment was clean and well organized. The parent information board was complete. The child and staff files were verified and found to be complete. The children's personal belongings were well stored and used for the intended child. The washrooms were clean. Monthly fire drills have been completed and documented. Proper hand washing and diaper changing policies were followed. Evidence of planned activities was present through "lesson plans". Learning stories with quotes and pictures of the children were posted on the walls. Recent Winter and Valentine's Day arts and crafts were on display.</p>
