General Comments

When I arrived for today's monitoring inspection, the children were participating learning invitations at tables that educators had set out for them. Some of the learning invitations that the children were observed playing with included a letter basket matching game, paper Easter egg painting, stacking eggs, Easter/spring sensory bin, and playdough.

Once the children were done with the learning invitations, one educator invited them to a carpet to sing a spring song, while the other cleaned up the table area. After the song, children then started to get ready to go outside to they could have a picnic at the picnic tables for snack. Educators were observed ensuring the picnic tables were properly sanitized before the children began eating.

The children were observed partaking in several different activities while they were outside. Some of these included playing on the play structure and on the climbing dome, hopscotch, making a tower and bridge with large Lego blocks, playing with basket/soccer balls, and playing with shovels and buckets. Educators were observed playing with the children while outside. Observed an abundance of positive child guidance practices while everyone was outside. Educators were quick to act when the children required assistance and ensured they were always getting down to the children's level when they were speaking with them.

Once it was time to go in for lunch, educators were observed helping the children clean up before heading in to wash their hands, eat lunch and have quiet time. Educators informed me that they planned to take full advantage of the nice weather and head outside to have another picnic this afternoon!

The playground that the children were playing in this morning is divided in two, please ensure that if children can play in both sides, that there is least one educator on each side of the fence to ensure proper supervision of both playgrounds.

The top cap of the 5th fence post from the building in the smallest playground (children were not in this specific playground during today's visit) was off, leaving a somewhat sharp top edge exposed. Childcare manager was able to put the cap back on as soon as it was noticed.
