General Comments

Children were observed tidying up for a quick circle before they were invited to do learning invitations that were set up at some tables. These learning invitations that were set out by the educators included cars with a road made out of tape where children had to drive their car and find the letters in their name, blocks for who can build the tallest tower, loose parts, foam block painting and a construction sensory bin.

Educators informed me that the children have been fascinated with the construction work that has been going on right in front of the facility, there are lots of big tractors, dump trucks, construction workers and a huge whole being dug in the road! Children were observed getting on chairs to get a better look out the window to see the work being done, educators were observed supervising the children as they were up on the chairs. Educators have planned a fun filled week of construction activities for the children because they are so interested in what is going on outside the windows!

Once children were finished with the learning invitations, they were asked to tidy up and wash their hands for snack. Educators were observed sitting and having snack with the children at this time. Since the rain has been holding off, the educators thought it would be a great time to head outside to play.

Outside, children were observed playing on the play structure, playing in the water with shovels and buckets, in the mud kitchen, and making potions with water, rocks and flowers that were found in the outside play space.

A couple children were observed in the smaller room with two doors when I arrived. A reminder that that particular room is not part of this licensed space and should therefore not be used unless the children are registered and signed into the other licence at this location. It is recommended that the doors remain close at all times to ensure children are not entering the space belonging to a different licence.
