<p>General Comments</p> <p>A Monitoring Inspection occurred on July 31, 2024.</p> <p>During the inspection, children were observed engaging in both indoor and outdoor free play. Educators mentioned that the children are currently very interested in being active outdoors for the summer, going on field trips, and creating imaginative games to play indoors. The educators were observed using positive language and giving gentle reminders to the children.</p> <p>Parents of children present at the center are granted entry at any time. Outdoor play is scheduled for at least one hour in each four-hour block of time when the majority of children receiving services are in attendance, weather permitting. The facility has a clearly visible and prominent place to post the license, current inspection report, current monitoring reports, and orders for compliance. Evacuation procedures are posted in a prominent location.</p> <p>The indoor space is set up to be inviting, with materials that encourage children to play. Books reflecting the children's interests have been selected. Several well-defined learning centers, including areas for building, reading, and dramatic play, are present. Traffic areas are kept clean, and outdoor walkways are free of clutter. Toxic products, such as chemical cleaners, are locked and inaccessible to the children. Drinking water is provided throughout the day, and outdoor stationary equipment is surrounded by protective surfacing of appropriate depth.</p> <p>The curriculum offers opportunities for both individual and group experiences. Children have ample opportunities to express creativity, explore the arts and sciences, experience accomplishments, problem-solve,</p>
