| <p>General Comments</p> <p>Preschool children were partaking in quiet play while a couple of their friends napped. Some activities that children were observed doing were drawing, reading books, playing with tabletop toys and just relaxing.</p> <p>Educator informed licensing staff that it was too cold to go outside this morning, so they had a balloon dance party instead with the children. Licensing staff was also informed that children have been discussing "community helpers" this week, there were many pictures of the children dressed as doctors, nurses, grocery store clerks and hospital cafeteria workers.</p> <p>Observed a child who was falling asleep on the couch, educator was quick to notice and provided child with a cot.</p> <p>School aged children were outside playing when I arrived. They were observed playing on the large play structure. Educators were also observed parking in children's games while outside.</p> <p>All staff files observed today were organized and found to be in compliance with Licensing Regulations.</p> <p>A reminder to ensure all children wear inside shoes for emergency evacuation purposes.</p> |
