## **General Comments**

The center appears clean. There is sufficient materials for the children. When I arrived the children were partaking in calm activities lead by an educator. They then had free play before lunch, and after lunch they had nap time. The nap area is spacious and there is enough space between nap cots. The outdoor area is spacious and the play structure has been removed, allowing for more space for the children to play. The operator is working on putting more surfaces in the outdoor area now that the weather is improving.

While there are lots of materials for the children, I also suggest making more defined play centers for the children in the indoor area. I also suggest that it might make it easier during transition times to find little activities or songs in order to occupy the children. Developmentally they are not at an age where they can sit still for any length of time.
