On two of the three occasions where children moved from one side to the other side, there were educators on the other side however, one of the three occasions, there was not another educator present on the other side of the centre. Please ensure that all children are supervised at all times to ensure the safety of the children.

Comments: Licensing staff observed an educator say in a raised voice, "No, go!" to a child while playing. Please ensure that positive child guidance is used at all times when interacting with children receiving services at the licensed facility.

On the day of the monitoring inspection visit, the children had a field trip to the local library. Licensing staff arrived at the centre as the children were leaving for the library.

Licensing staff noted an abundance of documented learning posted on the walls for the children to re-visit the learning experience. Well done!

The children were observed playing with play doh, Lego, babies and Barbies.

When licensing staff was speaking with the operator, the operator told licensing staff the centre had a preschool graduation for the children who are heading to kindergarten in the fall. Licensing staff saw pictures of the children with their graduation cloaks on, as well as, pictures of the children and their families enjoying the celebration.
