### General Comments

Upon my arrival, one group was getting ready to go outside and the other three were inside. The preschool children were doing an art activity. One on dandelions and the other on caterpillars. During the activity, the educators were engaged with the children, encouraging them, providing positive reinforcement, and also having educational conversations with them such as talking about colors and letters associated to the subject of the project.

The classrooms are clean and well organized.

The classrooms are all equipped with different materials to meet the interest and educational needs of the children. There are many different materials for literacy such as books and pictures and words on the walls. Loose parts and sensory materials. Materials to learn colors and letters. Puzzles and art supplies. Everything is labelled with pictures and words. Every room also has a picture routine posted on the wall.

The educators planning sheets are posted on the board of each classroom and there are many learning stories. There are also photos of the children engaged in play posted on the walls. The children's drawings and art are also posted on the walls.

Positive child guidance was observed such as gentle reminders about being respectful with our friends, staff were observed talking to children at their level and lots of encouraging words and positive reinforcement was heard.

The educators were helping the children to get ready to go outside but also encouraging independence and teaching them how to zip up their jacket.

The educators were observed taking all the opportunities they could to have educational conversations with the children. For example, when they were outside, there was a big yellow construction truck, and the children were fascinated and excited to see it. One educator started talking to the children about the colors that the children could see on the truck.

General Comments

The playground is well maintained and meets regulation. There are lots of colorful murals, the children have access to different materials such as mud kitchens, sand boxes, climbers, chalk boards, a music wall and many other items. The educators were engaged in play with the children outside also.

Everything is in compliance, I recommend for renewal.
