Comments: Currently the Centre has an Administrator and only one staff out of three with their Early Childhood Certificate. However, the Operator is enrolling in an approved ECE program so that she can be the Administrator and meet this regulation. There is also one other staff who is currently enrolled into an approved ECE program. An exemption request will need to be sent to the department to be exempt from this regulation temporarily until both individuals have completed their programs.
