General Comments							

Monitoring inspection visit performed.

Upon arrival children were doing clean up, washing hands, waiting for their friends to sit down and eat lunch. The educator also sat with the children while they ate lunch and enjoyed pleasant conversation time.

A small group of children in attendance today and all children napped a good 1 1/2 hours. Normally the children do not nap this long, and no child was required to nap, but all children did. Once children waked, they all had a toilet break, washed hands and played with sensory bins. The plan is to get ready and go outdoors after eating snack. The educator was overheard saying to the children 'that is so nice, okay my friends its time, do you need some help, did you have a good sleep."

Administrative records were reviewed, and attendance is tracked daily. See comments regarding fire drills and

documenting incidents. Potential illness forms are being completed also and I suggested emailing a copy to the parent for their records as there are instructions for parents to follow.

Licensing staff offered some tips to the Operator to help with organizing her files and staying on track for practicing fire drills by setting up a reminder on her phone calendar. The Operator is in the middle of completing her Micro-credentialing course and her other educator is on target for meeting the 10 hours of Professional Learning.
