General Comments

Children and adults gathered on the rug for together time and a read aloud. The educator read two books to the children involving them by asking questions, expanding on new vocabulary and reading with lots of expression. Afterwards, children can choose a centre for play. An educator sat at a table with magnetic letters and printed the letters on cardstock talking about letters as children joined. The educator expanded this area with oats on a tray and children able to trace letters. Another educator built soft blocks with children reminding them to ask others for an item to play.

The room is set up with accessible resources throughout and soft elements such as chairs, pillows, and scarves. The space is clean and organized. Documentation is posted throughout the centre with photos and curriculum connections. Children's photos are included in several areas such as a birthday tree with photos and a family tree with photos.

Children are familiar with the routines and reminders are given of upcoming transitions. The adults and children

sit together for lunchtime with the children noticing if an educator is taking longer to sit down showing their familiarity with this part of their day.
