### General Comments

Upon arrival of licensing staff, the children and educators were reading a book in the cozy corner. After the book, they did the "snowy pokey". The children and educators danced and sang together. They sang another song, where the children took their turns trying to find "the red undies for Pete". The children would take a cutout from the box, see what colour it was and see if it fit on the picture. The children were heard laughing as they sang. They then sang "a friend of mine" and were observed dancing with the other children. After circle time, the children engaged in free play.

The children played in the sensory bin, built structures, played with babies in the dramatic play corner, and some played a matching game. The educators were engaged and playing with the children. One educator set up an ice painting activity, and the children took their turns painting with the colourful ice cubes while the others continued their play. Some children played with Legos and others with board games and board puzzles. After painting, some children sat at the table with an educator to practice cutting with paper and scissors. The educator was heard praising the children. The children and educators started cleaning up the play area and gathered in the cozy corner to sing songs while some educators set up their lunches and prepared their nap cots.

The children took their turns washing their hands and sat at the table for lunch. The educators sat with the children and engaged in conversation with them as they ate. After lunch, the children used the washroom, washed their hands, and put their lunchboxes away, and the educators cleaned up the tables. The children got settled on their cots and read books as the educators helped them get tucked in. The educators sat by the children as they fell asleep.

The room was decorated with snowflakes, blue and glittery drawing, and a winter-item tracing activity they had done. The indoor environment is clean and well-organized. Child files were reviewed. The educators are attentive to the children, help them problem-solve, and engage in their play. Only positive child guidance was
