<p>A Renewal Inspection was completed today. The children were observed having morning snack, listening to a story, playing in the outside play area, lunch and afternoon play both inside and outside. One group of children had lunch outside and the other had lunch inside. Handwashing was observed occurring numerous times during the inspection visit.</p> <p>Educators were observed interacting with the children in their play. They were also observed helping the children problem solve when it came to taking turns using the shopping cart to transport the dolls.</p> <p>Discussed attendance records and to ensure that each group has their attendance records with them at all times.</p> <p>Several forms of documentation were observed: webs, learning stories and children's art. Well defined interest centers are set up throughout the room with age-appropriate materials for the children to interact and engage with.</p>
