General Comments

A Monitoring Inspection was completed this afternoon. Upon QAM's arrival, children were lining up at the door, getting ready for outside snack and play. The inside facility was inspected while the children ate their snacks, outside. Several well-defined learning centers were observed (dramatic play, arts & crafts, reading area, building & transportation, and science). Several forms of documentation were observed - word webs, children's

artwork, photos of family members and animals, etc. Several forms of documentation regarding things that fly were also observed. Educators stated that the children have recently been very interested in airplanes. Children were also observed outside. The outside play area had several materials, equipment, and activities for the children. Children were observed sliding, driving cars, playing catch with an educator, and finishing up their snacks. Educators were observed using positive child guidance - using positive language, redirecting negative behaviors, and taking part in play.
