When licensing staff arrived, children were gathered around the art table painting backgrounds for their selfportraits they had created previously. The children showed a since of pride as their educator showed licensing staff their drawings of themselves. The children's work shows how they actively represent themselves artistically as they transform their vision from one to another. As children take a closer look at themselves, they begin to see what makes them unique.

The environment was set up with a variety of accessible, well organized and open-ended materials in all areas to support playful exploration. Books that support the children's current interests were displayed in all areas of the room. Documentation with child's print was beautifully displayed around the room, which is reflective of children's current interests, curiosities and passions. Documentation of Mini Blossoms Olympics was displayed of the children making their own uniforms, holding their opening ceremonies and competing in Track and field, Tennis, Archery, Soccer and Gymastics. Ensuring that children participate in planning, changing and caring for the environment.
