Educators were observed reading to the children, engaged in conversations with them and observed in imaginary play.</p> <p>Invitations for learning were set up in the rooms. It was observed in the 3/4 year old room that a caterpillar had hatched into a butterfly. A web regarding caterpillars was being created by the educators with the children's ideas to expand their learning. In the 2 year old room the children were observed having snack. The infant room the children were observed in snack and play with their educators. The school-age rooms, the children were observed in outside play as well as creating art projects.</p>
