<p>A Monitoring Inspection was completed this morning.</p> <p>3/4 Room - children were observed sitting at their tables, eating Cheerios at QAM's arrival. . Educators were observed sitting and conversing with the children. Several learning stories were observed throughout the room, as well as several examples of the children's artwork. Well defined learning centers were observed - Building / Vehicle area, Dramatic Play area - Barbie and Barbie Dollhouse, Babies, and a play kitchen. A cozy corner was also observed - comfy couch, chair, rug, books, puzzles, and a Christmas tree</p> <p>2's Room - Children were observed sitting at their tables, finishing their Cheerios upon QAM's arrival. Several forms of documentation were observed - word webs, learning stories, and children's framed artwork. Educators stated that the children are presently very interested in superheroes, the Holiday Season, dress up, and toy vehicles. Clearly defined learning centers were observed - dramatic play, building area, cozy reading area, and an arts and crafts area. Educators were engaged with the children - giving gentle reminders, assisting in transitioning from mealtime to play, and providing encouragement and praise.</p> <p>Infants - The children were observed during outside play. Children were observed playing with trucks. Educators stated that the children are presently very interested in vehicles, books, and babies.</p>
