General Comments						

A renewal inspection occurred today.

The children were observed during morning snack, outside and inside play, lunch and nap/quiet time.

Handwashing and diaper changing was also observed during the inspection.

Discussed with Operator the requirements for Inclusion Support Workers to take the Professional Learning Webinar "Tools for Inclusion".

Discussed with school-age room and having defined interest centers. It was observed an art shelf with materials however the paper for the children to use was on the other side of the room. Recommending that the Operator review Appendix 24-Equipment and Materials for School-age Children with the educators.

General Comments

Also discussed the use of wading pools that were observed in the school-age outside play area. When the educators were asked what they used them for, the Inspector was told they fill with water for the children to play in. Under the Public Health Inspection Standards 2.3 Outdoor Play Area/Equipment it states: "Portable wading pools are not permitted".

Questions were also asked about the use of glass jars/mason jars for storing markers/pens/pencils/ making potions in. These can be used. Discussed that if taking outside to make "potions" in, that this should be done away from the area that the children are playing soccer.

Each of the learning environments have the children's current learning displayed in various forms of documentation, learning stories, art, pictures, and webs.
