Examples of materials to include, but are not limited to variety of paper in colours, textures and sizes, paint, paint brushes, paint rollers, mark making materials, glue, tape, feathers, tissue paper, cardboard tubes, fabric, yarn, ribbon, recycled items, items collected from nature, collage materials, etc. After-School Program: Dramatic play materials depleted. Examples of items to add, but not limited to costumes, hats, scarves, purses, office supplies, restaurant items, clipboards, cash register, money, pretend food, real life items, loose parts, tools, items that support the children's interests.

<p>Monitoring Inspection:</p> <p>Children and educators observed engaged in variety of activities this afternoon including dramatic play, playdoh, music, outdoor play, open-ended art, board games and gross motor play. Purposeful planning is evident through documentation, invitations and materials added to the environment that support the children's current interests (bugs, flowers, Frozen, art, movies, forts, soccer and basketball). Each child has a portfolio with photos and documentation to revisit.</p> <p>QA Monitor discussed positive child guidance techniques with operator during inspection. It was noted that some staff were using negative language towards children. Educators to use positive language when speaking with children and redirect children when problems occur. Operator is going to reach out to Early Learning</p>

Consultant for recommendations on Professional Learning topics around Positive Child Guidance.

Handwashing routines observed after outdoor play and at arrival.
Incident logs were observed to be completed and signed by guardians.
Daily attendance forms are completed and accurate.

QA Monitor discussed the climbing dome in the after-school outdoor play area. Climbing dome is too close the cribbing and fence. Ensure manufacturers guidelines are reviewed and followed.
