<ul> <li>Discussion with educators: <ul> <li>on how to respect ratio when support workers are present in the group;</li> <li>employee's files must be available at all times and kept at the facility.</li> </ul> </li> <li>A support worker who does not yet have her first aid and CPR course is not to be alone with children. She must be with someone who has a valid certificate at all times.</li> <li>All educators have completed their 10 hours of professional learning.</li> <li>Observations: <ul> <li>The 2-3-year-old group created art and colored. The children participated in free play and then went for a walk.</li> <li>When they got back, they sang songs from the song box by picking objets associated with a song.</li> <li>The 3-4-year-old group went outside to play, and they did paintings with long wood and cotton tips.</li> <li>One group of the school age children were at the library and the other group participated in free play. Some children were building with big foam puzzles, others were creating with Legos and tracks, others were creating books and more. They went outside and after, the educator read a book to the group.</li> <li>All groups had their snack; lunch and the younger children had their nap period.</li> </ul> </li> </ul>
