<p>- Children to staff ratio is respected during renewal inspection.</p> <p>- One educator needs to complete 3 more professional learning hours by December 31st, 2025. A plan is in place to complete the hours.</p> <p>Observations:</p> <ul style="list-style-type: none"> - All children were outside at my arrival for the renewal inspection. - When they came back inside, the 2–3-year-old group used their song box to sing songs. The 3–4-year-old group painted snowflake ornaments and played with slime. The 4-year-old group played with Play-Doh and the educator read a book to the group. - All children ate their meal and had a nap. Children who did not sleep had a bin with toys to play with. - When children woke up, they all ate their snacks. <p>The facility meets requirements for Licensing Regulation - Early Childhood Services Act. Recommending licensing for another year.</p>
