Invitations were observed on tables/shelves that inspire exploration and engagement. Educators were comfortable playing, engaging and participating in children's play indoors and outdoors. All staff files were observed and complete. A random review of children's files was also observed and complete. One child's file missing second emergency contact however, it was discussed that they are not from the area.
