Each classroom had an opportunity to make their own dumpling and take part in Tai Chi with a Tai Chi Master who came to the centre to help the centre celebrate Chinese New Year. The children also created some chinese art to prepare for today's celebration.</p> <p>All classrooms had an abundance of documentary evidence posted on the walls for the children to re-visit their learning experiences.</p> <p>All classrooms child-to-staff ratio were within regulation according to the Early Childhood Services Act.</p> <p>All educators were observed using positive child guidance techniques when experiencing undesired behaviors by redirection along with taking a child aside to help them work through their feelings.</p> <p>Educators in all classrooms were observed engaging with the children at the child's level.</p> <p>Despite the snowy weather, the children had opportunities to play outside, and the infants went on their daily walk.</p>
