Proper Diaper Changing and Handwashing was also observed occurring numerous times throughout the day. Educators were observed engaged in the children's play and learning as well as conversations. Discussed outside play during the winter months, being mindful of when children are saying they are cold and to come inside. Ensure children and staff are dressed appropriately for the weather for outside play. The children's learning is documented and displayed in the learning environments for them to revisit at any time. Educators were also observed speaking kindly and respectfully to the children, redirecting behaviors appropriately and tending to their needs.
