A Monitoring Inspection was completed this morning. There was a newer educator in the preschool aged room. This educator was in the process of organizing the play space and making it their own. Preschool children were observed playing with toy vehicles, a fishing game, playhouse, and baby dolls. Educator was also observed reading a story to the children. Children were observed washing their hands before lunch. Children were served Sloppy Joes.

The Infants were observed playing with balls - putting them in and out of a large container. Infants were also observed looking at books and playing with wooden blocks. Infants were observed during hand washing procedures and they were also observed sitting at their table, awaiting their lunch.

Documentation was observed throughout the facility.

A conversation was had with the Administrator regarding the organization of materials throughout the facility. QAM was informed that staff are in the process of organizing rooms, bins, and toys, throughout the facility. During Staff File Review, QAM noticed that one staff file was missing. This staff had to leave the facility, and a conversation was had with the Administrator, that the employee would not be able to work, or be in facility, until the completed file was added to the Staff Binder.
