friends. Several forms of documentation were observed throughout the room. Positive child guidance techniques were observed - educator using positive language when interacting with the children. Diaper changing was observed and diaper changing procedures were followed.

Polar Bears - Children were observed playing with toy vehicles. Positive child techniques were observed - redirecting negative behaviors, encouraging sharing, and offering praise.

Panda Bears - Observed inside and outside. While inside, the children were observed during snack. Educator was observed reading a story to the children, while the children ate their snacks. Educators were observed giving compliments and offering encouragement, during snack and during the transition from snack to outside play. While outside, the children were observed in the woods, gathered in a clearing, singing songs.
