Comments: Only the administrator and one staff member holds a one-year Early Childhood Education certificate. The administrator and 50% of educators must hold a one-year Early Childhood Education Certificate or training that is equivalent. The plan provided by the administrator to meet this regulation, back in January 2024, has not been successfully achieved. To this day, the plan has not yet been achieved. The administrator must submit another detailed plan and take action immediately.			
12(0.1)(a)(i-iii) In subsection (1), an operator of a licensed facility includes: (a) in the case of a criminal record check or a vulnerable sector check, as the case may be, (i) in the case of a corporation or unincorporated association, the directors, (ii) in the case of a partnership, the partners, and (iii) in the case of a limited partnership, the general partners;	12(0.1)(a)(i-iii)	Feb 27, 2026	
Comments: All board members must have a criminal/vulnerable check. Two board members did not have their checks. The checks must be provided and place into their files.			
12(3) An operator of a licensed facility shall ensure that a criminal record check or a vulnerable sector check, as the case may, and a check with the Department of Social Development is conducted on each staff member and associated person at least every five years.	12(3)	Feb 27, 2026	
Comments: The administrator criminal and vulnerable record check is expired. A new copy of the checks must be provided every 5 years.

Comments: Application for change in service must be sent in order to make changes. Administrator will need to send an application for change in order to continue the changes.			
28(2) An operator of a licensed facility shall carry out emergency evacuation and fire drills monthly.	28(2)	Feb 27, 2026	
Comments: Emergency evacuation and fire drills must be completed and documented each month. The administrator did provide documentation, but a month was missing. Administrator mention two drills will be done and documented this month.			
33(3) An operator of a licensed facility shall complete a monthly review and maintenance plan on all stationary equipment that includes the following information: (a) the review and repair dates; (b) the action required and the action taken; and (c) the name of the staff member who conducted the review.	33(3)	Feb 27, 2026	
Comments: The administrator was not able to provide documentation that a monthly review is being completed on all stationary equipment in the outdoor play area. A monthly review and maintenance plan must be completed on all stationary equipment showing: the review and repair dates; the action required and taken; and the name of the staff completing the review.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Feb 10, 2026	Feb 10, 2026
Comments: A canister of Lysol wipes is in a basket on a shelf in one of the classes. All toxic products must be locked and inaccessible to children. The educator is advised and immediately locks the canister of wipes. Deficiency is now compliant
