Open-ended, age-appropriate materials are available in each of the rooms for the children to interact and engage with to enhance their learning experiences.</p> <p>Educators were observed tending to the needs of the children appropriately. Actively engage in their learning and play.</p> <p>Recommending that all emergency exits plans be redone and the new divisions of the rooms that have occurred since the initial licensing of the facility, be indicated on these drawings.</p>
